Query about progress on barn fire case – Inspector Trevivian said investigations were ongoing and they have the names of possible suspects

a) Police – Sector Inspector Trevivian. New Beat Manager recruited and they will be allocated to china clay area. Team is preparing for summer. Asked that ASBs be reported to have a better picture of the problem. He has received extra funding for tackling antisocial behaviour, 50% for extra patrols and the 50% to Young People Cornwall for youth work and support services.

b) Amanda Pennington – Wildanet

services to individual properties.

Wildanet was founded in 2017 and now has 230 full-time staff
Has contracts with UK government (as part of their £5bn Project Gigabit programme) to
bring fibre broadband to 39,000 homes and businesses in Cornish rural areas so that
internet connections are functional and fit for purpose. Funding is for getting connectivity
to the last 5% of hard to reach properties. They are building the infrastructure and using
existing infrastructure (eg underground ducting) if it is sound, rather than providing internet

c) Local Plan - Robert Lacey - Planning Policy Manager

Current CLP remains in place to 2030 but is being rewritten due to

-local planning changes eq

registration scheme for short-term lets being introduced summer 2024

community support required for renewable energy sources eg solar farms, wind turbines support to develop brownfield sites

changes to permitted developments

- adoption of Climate Emergency DPD in February 2023
- impact of population growing, climate changing, social needs changing

Neighbourhood Development Plans will feed into the local plan – but need to provide very local policy in addition to what is in the local plan eg focus on design

Neighbourhood Priority Statements are additional to NDPs. No policies but identify key priorities for local area, including development preferences, natural environment, housing. Need to go to local consultation and be endorsed by Cornwall Council.

Guidance on writing local plans still being issued by UK government so what a local plan will include is still to be finalised.
